



CONTEST RULES AND REGULATIONS

HOW TO PARTICIPATE

1. Eligibility: Royal City Nursery's "Stupendous Sunflower Saga" Contest ("Contest") is open to all residents of Ontario, except employees of Royal City Nursery, employees of Royal City Nursery's advertising agency and members of the immediate family of any such persons not eligible to participate. The term "immediate family" includes spouses, siblings, parents, children, grandparents and grandchildren, whether as "in-laws" or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether related or not.

2. Contest Period and Entry: Eligible Contest participants may register for the contest by visiting the Royal City Nursery location between the dates of April 21st, 2018 and June 1 2018 during store hours. To register, contestants will be required to provide information including their full name and contact details (e-mail address, phone number and complete mailing address) at Royal City Nursery. Under no circumstances will registrations be accepted after close of business on June 1, 2018.

3. Contest Entry Restrictions: Only one (1) entry per person. Only one (1) entry per household. Only one (1) prize will be awarded per household for the Contest.

THE CONTEST

1. The Race: Starting between April 21, 2018 and September 22, 2018, contestants will grow a Sunflower. The complete heads can be fresh cut or dried, must be submitted for measuring no later than noon (12:00 pm) on September 22, 2018.

2. The Measurement: Complete Sunflower heads will be measured on the face, excluding the surrounding petals, not on the overall height of the plant. In the case of a tie, the sunflower with the most complete seed head will be declared the winner.

PRIZES

1. Prizes: will be awarded as follows:

- One (1) Grand Prize of a \$500 ROYAL CITY NURSERY Gift Card and \$200 (retail value) of West Coast Seeds
- Two (2) Second place winners each receive: a \$200 ROYAL CITY NURSERY Gift Card and \$100 (retail value) of West Coast seed

2. Awarding of Prizes: Subject to the Rules and Regulations of the Contest, all Prizes will be awarded to one eligible contestant whose name and address appear in the Contest registration database. The Prizes will be awarded in the following manner:

a. The one (1) Grand Prize will be awarded for the sunflower head which is the most complete and measures the largest in diameter

B. two (2) Second Place Prizes will be awarded to the second largest (diameter) and complete sunflower heads

3. Other: The Prizes awarded to eligible winners are not transferable, redeemable for cash or exchangeable for any other prize. The Prize winners will be announced on September 7th 2017. If a winner cannot be contacted or is disqualified for any reason, Royal City Nursery reserves the right to determine an alternate winner or not to award that winner's prize, in its sole discretion. *Please note: Royal City Nursery Gift Cards are not redeemable for services.

GENERAL RULES

1. Contest Sponsor: The sponsors of this contest are Royal City Nursery and West Coast Seeds.

2. Prize Claims: All prize claims are subject to verification by Royal City Nursery and/or their assigned representatives. Entries made with multiple addresses and/or multiple identities that are in excess of Contest rules will be disqualified.

3. Submission: If a dispute arises regarding who submitted an entry, Royal City Nursery and/or its representatives will deem the entry to be submitted by that person whose contact details match those in the Contest database.

4. Release: By participating in the Contest, each contestant (including any and all winners) agrees to the following:

- to be bound by the Rules and Regulations and all decisions of the Contest Sponsor;
- to the collection and use of his/her personal information by the Contest Sponsors;
- to release and hold harmless the Contest Sponsors, their employees, agents, directors, officers and representatives from any and all liability for any claims or

liability whatsoever arising from their participation in the Contest and/or their acceptance and use of any Prize awarded;

- to permit the Contest Sponsors to use his/her name, address, city, province of residence, photographs, voice, video and/or other promotional material in any medium or format for any advertising, marketing and promotional purposes without any additional compensation or remuneration for such use; and
- to sign an Official Waiver upon registering for the contest to this effect.

5. Conduct and Decisions: By participating in the Contest, contestants agree to be bound by all decisions of the Contest Sponsor. Contestants who violate any rule, gain unfair advantage in participating in the Contest, grow their Sunflowers using banned substances or obtain winner status using fraudulent means will be disqualified. Disruptive, harassing or threatening behavior is prohibited. The Contest Sponsor will be the sole arbitrator of all Contest rules. The decisions of the Contest Sponsor in relation to the Contest will be final and binding upon all contestants.

6. Prizes Awarded: Under no circumstances will the Contest Sponsors and/or its representatives be required to award more Prizes than listed in these rules and regulations. In the event of a tie for any prize, one (1) winner will be randomly selected from the tied contestants.

7. Laws: The Contest is subject to all applicable federal, provincial and municipal laws and regulations.

8. Contest Cancellation: The Contest Sponsor reserves its right to terminate or suspend the Contest at its sole discretion for any reason that it deems appropriate that adversely affects the integrity, administration, fairness, operation or outcome of the Contest.

9. Contest Database: The Contest Sponsor shall not be responsible for incorrect Contest registration, technical errors or malfunctions, lost or incomplete registrations or any other registration discrepancies due to human or technical error.

10. Minors: In the event that minor contestant claims a Prize, an adult legal guardian shall accept the Prize and sign any required documentation.
